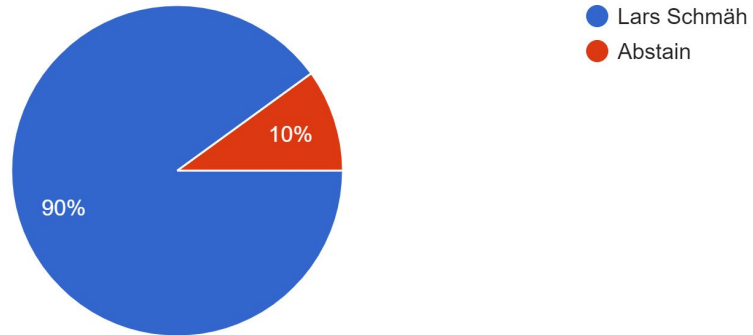

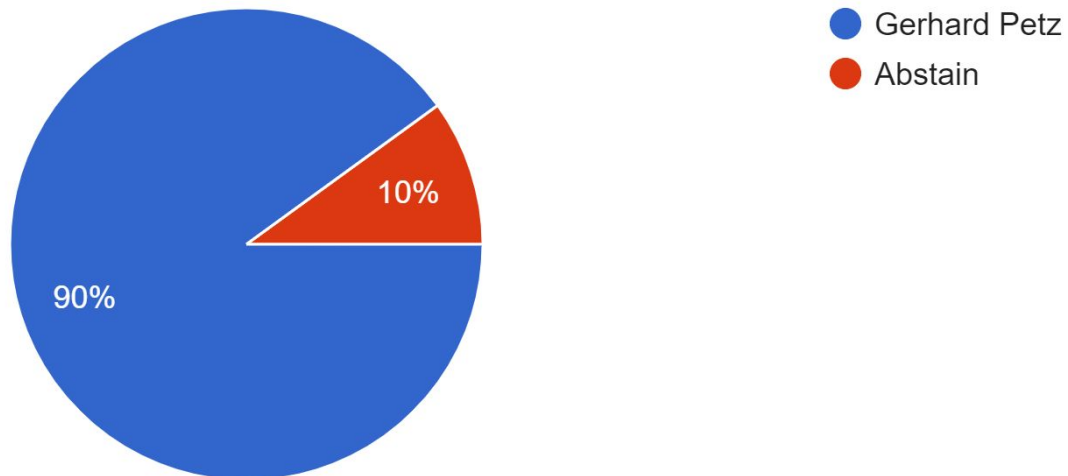

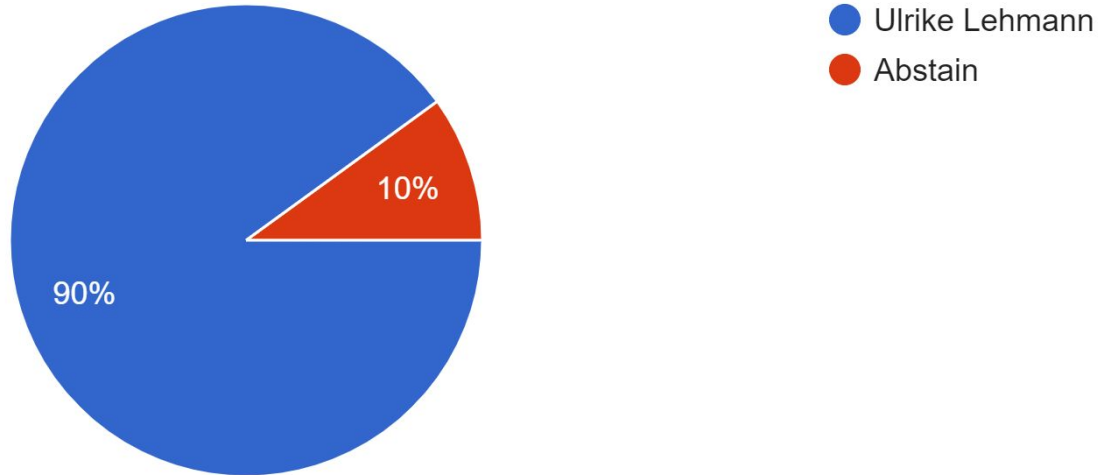

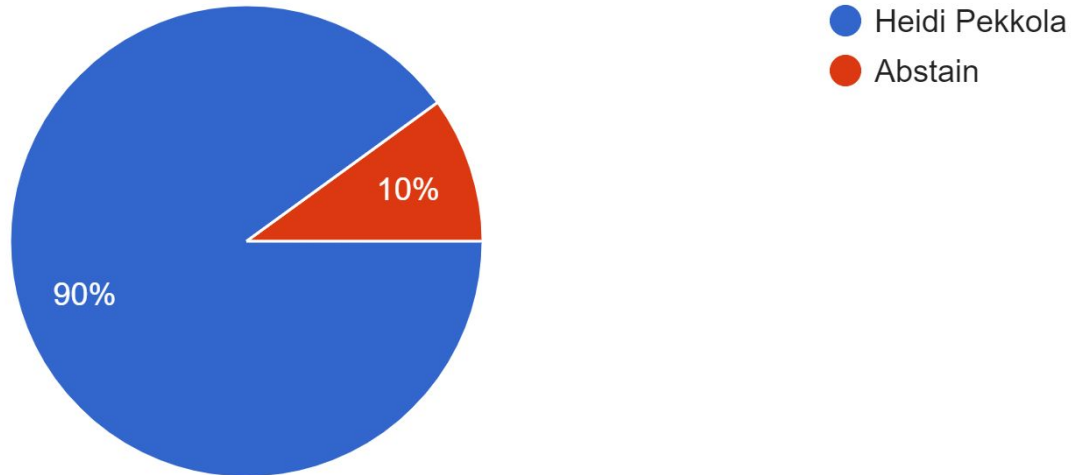

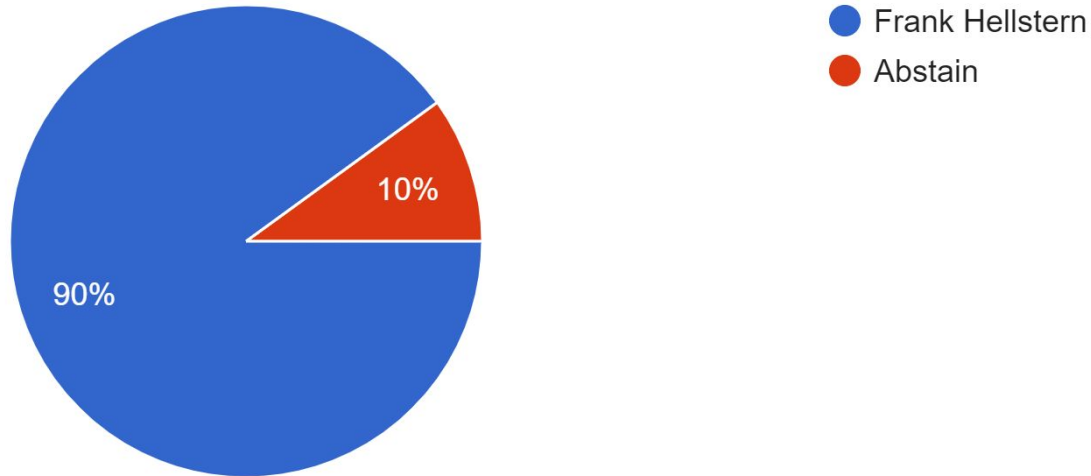

Auditors elections Vote is Open



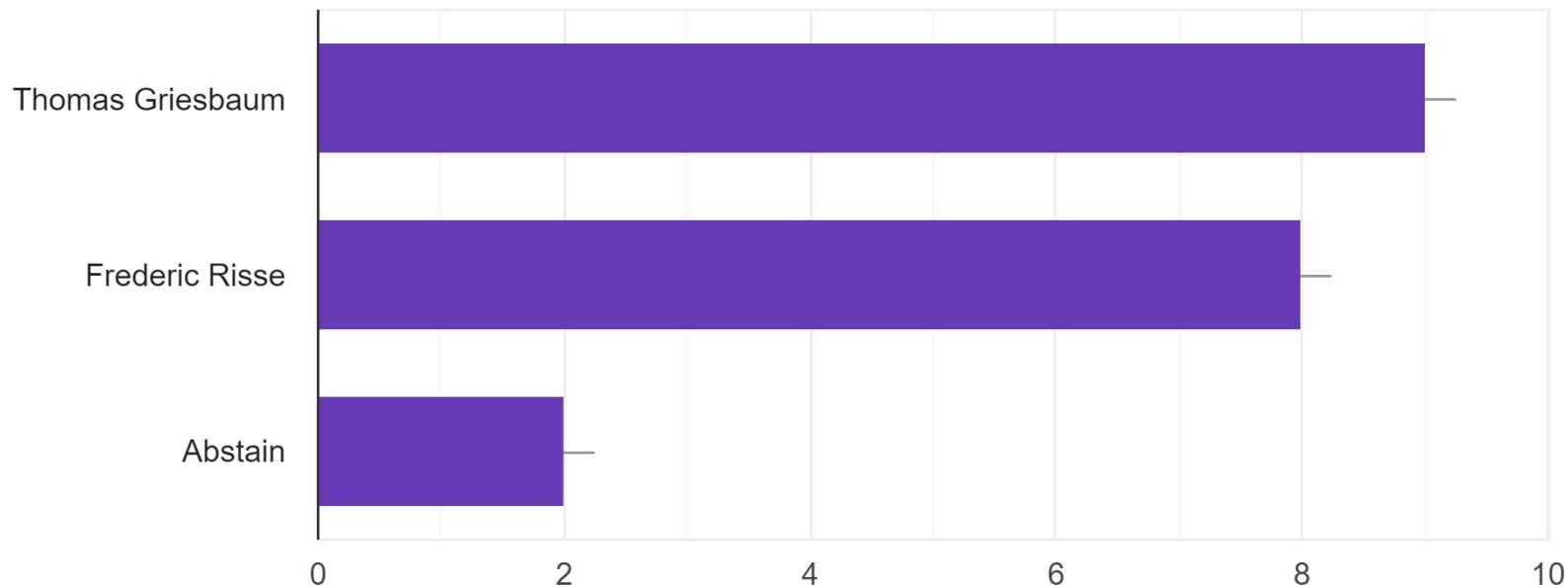

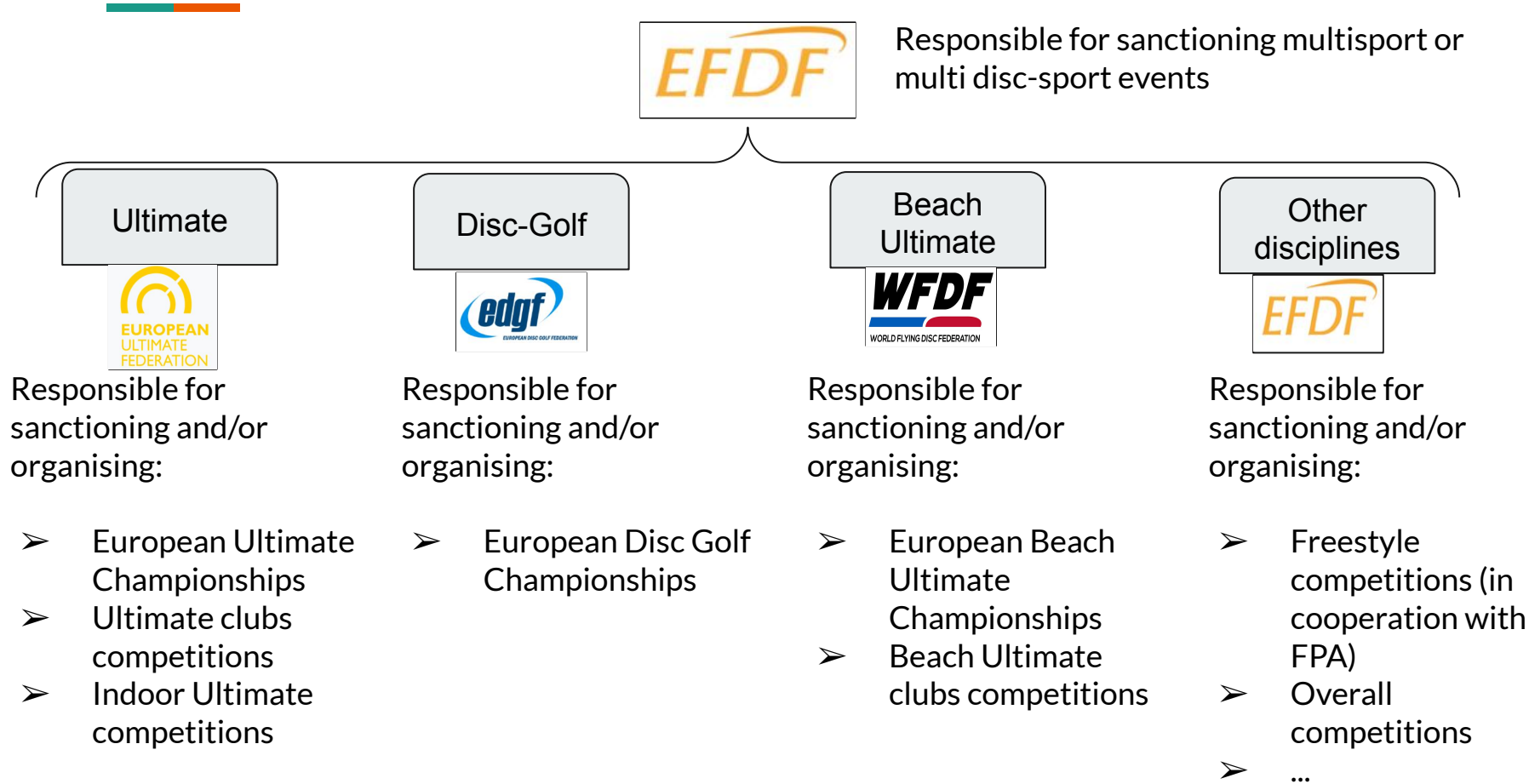

Purposes of EFDF (§2)

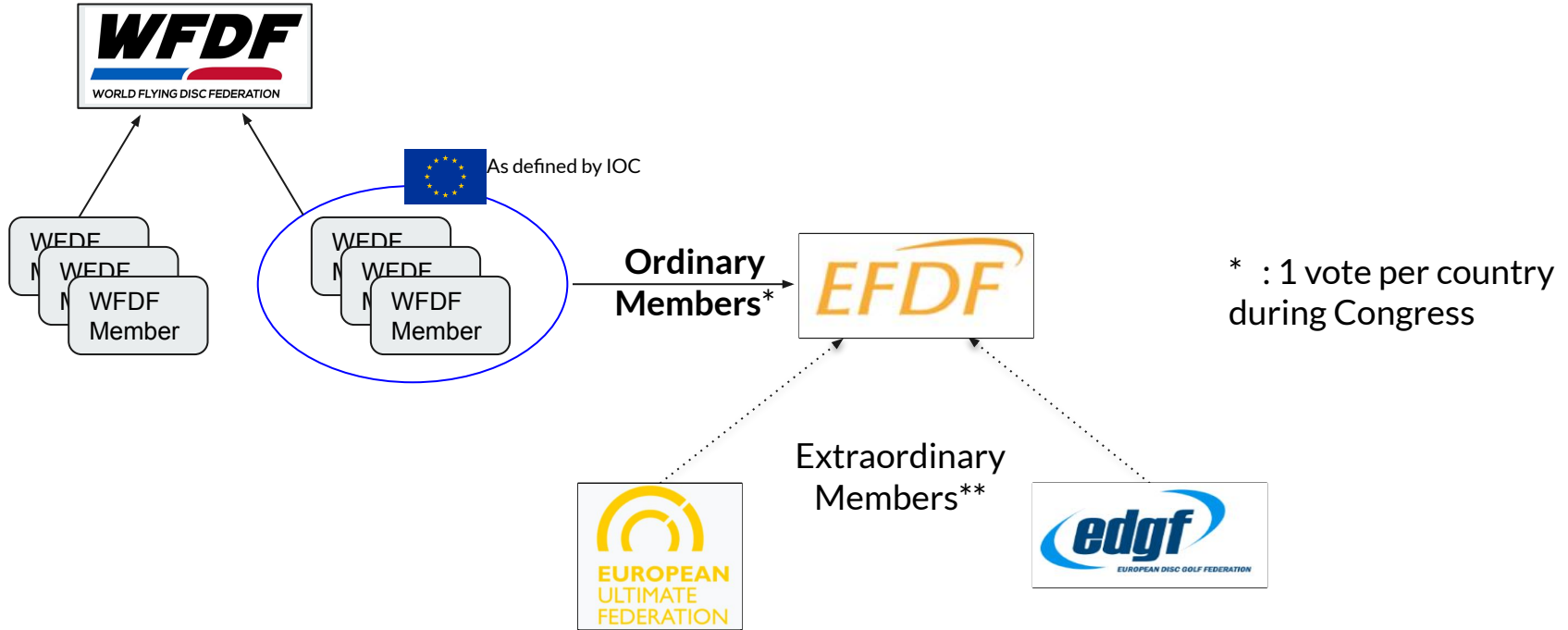
- Foster sports and flying-disc sports recognized by WFDF
- Represent Flying disc sports recognized by WFDF in front of European sport and institutions organisational committees of multisport games (EOC, EUSA...)
- Represent European Flying-disc sports before multi-sport events organization committees
- Support WFDF activities in Europe
- Create a forum for Flying-Disc federations in Europe

- Fostering the creation of European sector-specific federations (Beach Ultimate, Freestyle...)
- Adopting the WFDF policies (except when there is a EFDF-specific policy)
- Fees :
 - **NO Ordinary membership fee** foreseen in the short and medium term
 - Extraordinary membership fee for EUF and EDGF: Amount to be defined
 - Events fee for to be defined on a case by case basis.
